## LEGISLATIVE UPDATE

As of April 27, 2010

The following ordinances are being followed by the Chamber and are on Council's front burner.

A new section to the Zoning Code has been created that establishes a permit process and regulates solar energy systems. These systems are a permitted accessory use in all zoning districts. Rules regarding setbacks, screening, etc., will be established.

The city has placed a moratorium on permits for premises that include mechanical or electronic gaming devices, video arcades or parlors, internet cybercafés and game room licenses until October 5, 2010 or the establishment of regulations applicable to these uses, whichever occurs first. Council feels that unregulated proliferation of these uses constitutes a nuisance which interferes with public welfare.

The city is considering an ordinance that will allow the city to assess your property for the cost of abating recurring public nuisance activities. The cost will be billed, and if not paid, will be added to your property taxes.

Certification of compliance with Renovation, Repair and Painting Rules issued by the EPA for lead based paint and window replacement must now be provided when a contractor registers with the city. A fee of \$75 has been added for this process. The EPA has classes where this certification is earned.
